CONTRACT AGREEMENT

THIS CONTRACT AGREEMENT, made and executed this _____ day of _____, between Marching Solutions, here-in-after referred to as the "party of the first part" and _____ here-in-after referred to as the "party of the second part". This contract is enforceable under all applicable laws in the county of Minnehaha, in the State of South Dakota.

WITNESSETH

That whereas the "party of the first part" and the "party of the second part" hereinabove stated desire to associate themselves in a contract agreement, and whereas subject to the terms, conditions, and provisions hereinafter set forth the party of the first part and party of the second part do agree as follows: The "party of the first part" is to provide a custom-designed marching show for the "party of the second part".

THE FOLLOWING SHALL BE THE RESPONSIBILITY OF THE PARTY OF THE FIRST PART

1. To provide a custom-designed marching show:
 - a. comprised on the instrumentation listed on the Instrumentation form, (If Applicable)
 - b. to the songs listed on the Musical Selection form (If Applicable)
2. To do everything within their ability to see that the drill charts are accurate and understandable. (if Applicable)
3. To provide copies of the show pages and coordinate sheets.
4. To offer consultation via phone or email.
5. To deliver the materials in the quickest and most efficient manner possible.
6. To provide color guard work via video tape explaining the routine so that is very easily understood. (If Applicable)

THE FOLLOWING SHALL BE THE RESPONSIBILITY OF THE PARTY OF THE SECOND PART

- 1.** To provide accurate information regarding:
 - a. Instrumentation (using the Instrumentation form)
 - b. Musical Selections (using the Musical Selections form)
 - c. Scores
 - d. Recordings- MP3 files
 - e. Preferences
- 2.** To only make as many copies of the material as needed by the organization.
- 3.** To not allow the show to be distributed to others outside of the organization unless first receiving permission from the show designer.
- 4.** To agree to pay the amount indicated on this contract, and by the conditions set forth below. The person signing this contract acknowledges that he/she is a duly noted representative of this organization responsible for authorizing payment.
- 5.** Agree to pay for services once work has begun. Cancellation schedule: Up to 1/2 of work completed = pay 1/2 of quoted price
More than 1/2 of work completed = pay full price
